### **NNDC Enforcement**

Two successful North Norfolk District Council prosecutions for waste offences

Always check you comply with laws governing disposal and transportation of waste

Two men have pleaded guilty to separate charges involving the illegal disposal of waste. The successful prosecutions were brought by North Norfolk District Council.

One man was charged with contraventions of section 34 of the Environmental Protection Act 1990 in respect of the householders' duty of care and failure to make such measures as are necessary to secure that any transfer of household waste is only to an authorised person. He gave his waste to an unknown man in a van who turned up offering to take his scrap and other waste at no cost. The householder pleaded guilty to the charge which related to waste tipped on Tatterford Road, Dunton, at Norwich Magistrates Court on November 17. He was given a conditional discharge for 6 months and ordered to pay £70.80 compensation, £150 costs and a victim surcharge of £20; a total of £240.80.

In the second case, a man was charged under the Control of Pollution (amendment) Act 1989 for the offence of transporting controlled waste without being a registered waste carrier and also for a duty of care offence under section 34 of the Environmental Protection Act 1990. The charges were in relation to waste deposited in Marlpit lane, Hempstead. The man had accepted an offer from someone who had offered to take the waste for £20. He pleaded guilty to two charges on November 17. Norwich Magistrates Court sentenced him to a six-month conditional discharge and imposed a £20 victim surcharge.

You must make certain that anyone disposing of your waste is correctly licensed to do so.

### Funding Boost for Communities Affected by Second Home Ownership

It has recently been announced that North Norfolk will benefit from a share of the £60m national fund designed to support the provision of affordable housing through community land trusts and other community led housing groups. It is too early to say how this funding will be used but *Homes for Wells* is a good example of the kind of approach that this new money will help to fund. This shows the district council working with a local community land trust to deliver affordable homes for our residents.
