b) North Norfolk District Council

NNDC planning office is experiencing delays in processing applications. Because of this the assistant director of planning has been asked to report to the monthly planning committee meeting on progress. Delays have been caused by staffing shortages both with NNDC staff and other organisations which it is necessary to get reports from before decisions can be made.

This year's "Greenbuild" will be held online rather than at Felbrigg. It will be held between 1 and 12 November to coincide with "COP 26". There will be workshops, debates and question and answer sessions. Subjects to be covered include decarbonisation, hydrogen wind and solar power, and communities working together on such projects as orchard gardens and energy schemes.

The Banksy artwork at Cromer has been covered to protect it from being defaced but will eventually succumb to the sea's power as it is below the high tide line.

NNDC have begun to discuss the high price of housing and whether second/holiday homes are a factor. Because of driver shortages there have been delays to some refuse/recycling collections, but at present these have been few and generally collections have been made at the normal time.
